Statement of Evidence:

NORTH QUARTER CORNER SECTION 20, TOWNSHIP 101 NORTH, RANGE 40 WEST, 5th P.M. NOBLES COUNTY, MINNESOTA

- 14 Oct. 1868 George G. Howe, U.S. Deputy Surveyor, his notes read: "East on random between Sec.s 17 & 20, Var. 11° 50' E." @ 40.00 chs. "Set temp 1/4 post". "S. 89° 40' W. between Sec. 17 & 20, Var. 11° 50' E." @ 40.03 ½ chs. "Set post in mound with pits for 1/4 sec. corner", no ties.
- Martin Land Surveying of Worthington, Minnesota, Job No. 82065, a survey signed by Gary D. Martin, RLS # 12967, notes for part of Section 17-101-40, state that he dug around 'T' fence post and found remnants of old wood fence post and set a ½" rebar at 'T' post location.
- Minnesota Department of Transportation, survey crew working on TH 60, SP 5305-51, found a rebar with plastic cap stamped RLS # 12967, down 0.2' for the North Quarter Corner of Sec. 20-101-40. Returning in the first week of Dec. 2003 to perform a GPS survey where the distance west of 2640.13' and a distance east of 2668.60' were computed to corresponding section corners.
 - * Gary D. Martin, RLS # 12967, owned and operated Martin Land Surveying, Inc., of Worthington, Minnesota and sold the business in 1987. Mr. Martin is now practicing in Holly Springs, Georgia.

The written evidence is weak and only goes back to 1982 where Gary Martin was convinced that the 'T' fence post represented the best evidence of the true corner location, and the occupational and collateral evidence support this is a reasonable location as to the corner.
