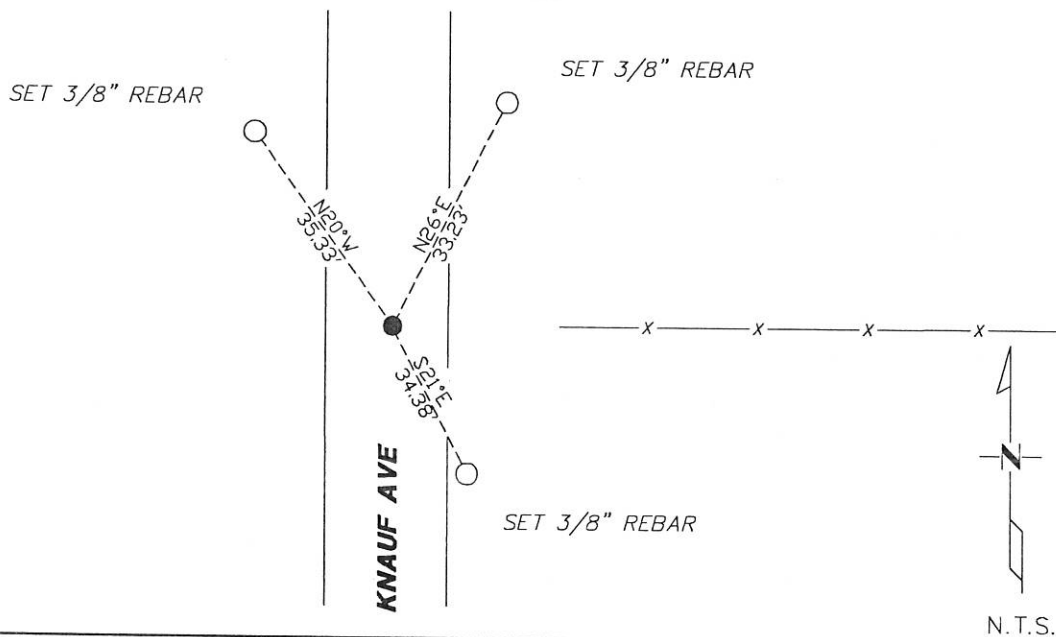

East Quarter Corner of Section 33, Township 104 North, Range 41 West, 5<sup>th</sup> Principal Meridian, Nobles County, Minnesota.

1868-Deputy Surveyor Richard N. L. Jeorlt, set a post in mound with pits for the section corner.

2013-Nobles County Highway Department "Corner Ties Book" calls for a found iron pipe at the corner location.

2013-A survey dated 12/12/2013 prepared by Perry L. Zieske, for project number N 1318 SB, shows a iron monument being in place for the corner position. The survey also shows a distance of 2658.96 to the SW of Sec. 34 T.104 R41.

2014-A survey dated 2/18/2014 prepared by Perry L. Zieske, for project number N 1318 SB, shows a iron monument being in place for the corner position. The survey also shows a distance of 2658.96 to the SW of Sec. 34 T.104 R41.

2017-On November 9th, Westwood Professional Services found a iron pipe capped 19789 on N/S centerline and online with fence line running east. Distance to the SW of Sec. 34 T.104 R41 shown on the 2013 and 2014 Zieske surveys match. Occupation agrees with the proportion distance. Accepting the found iron pipe capped 19789 as the best available evidence of the corner position. Set 3 ties.
